The Abductions

In previous chapters, I described the history of Nephilim and Watchers as revealed through the writings of Enoch and Moses. Those ancient holy men created a mosaic of revelations about those days of old which have been cross-checked, logically connected, and fully documented in this book. 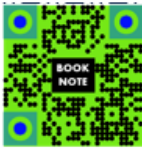
Before we proceed, it should be noted that the covering up of giant skeletons has occurred in every nation, since time has begun and each time the evidence is evidently lost or destroyed.



What are we to make of UFO craft—which encapsulate all of these features to some degree? In this context, we ought to confront the profound possibility that these entities hail from a dimension beyond our own: a dimension we can only describe as supernatural or spiritual. These extradimensional beings defy our moral judgments, as they range from benevolent spirits to malevolent forces. Their values are not ours; their morals are not ours; and their goals certainly are not ours.

To discern the intentions of these entities, we must examine their actions: the projects they undertake, the results they

seek, and their ultimate objectives. It is through their deeds that we glimpse the essence of their existence, not through their appearance or mystical powers.

Encounters with these entities often lead to unsettling outcomes. We can classify them as either benevolent spirits, akin to angels or messengers, or malevolent forces, like demons or even The Dragon. Malevolent entities invariably seek to sever our connection with God and Jesus Christ: a telltale sign of their dark intentions.

But, why do these extraordinary phenomena manifest more frequently in specific regions of the world, such as Equatorial Brazil, France, and Alaska? Could there be a connection between the occult practices of certain countries and their susceptibility to UFO sightings, abductions, and unexplained phenomena?

The question then arises: how do these travelers navigate the thin veil between dimensions? The answer lies in the concept of a Portal: a gateway through which entities pass, bridging the divide between worlds. The appearance of these Portals remains elusive, though, with claims of discovery met by intrigue and skepticism.

But, amidst these mysteries, another revelation comes forth: the true nature of the entities conducting human abductions. Contrary to popular beliefs, they are not benign extraterrestrial visitors seeking genetic material for benevolent purposes.

Are the Greys from Zeta Reticula attempting to address a genetic problem within their own species, or are they simply procreating non-human entities to further some enigmatic objective, much like the Watchers did in ancient times during the Seed War?



SABER AVATAR

Deep within the classified recesses of the highly secret Project Aquarius—the part of the US government which interfaces with UFOs—a covert name for the artificial lifeform has been leaked. The compartmentalized code name is “SABER”: an acronym standing for “Synthetic Astro-Biological Extraterrestrial Races.” SABER refers to those enigmatic beings known as Greys. Greys are not aliens, contrary to popular belief, but rather advanced androids: anomalies of artificial organic life. In short, Greys are biological machines. Notably, Greys transcend the boundaries of physics and they are capable of passing through solid matter and existing in their own space-time.

SABERs engage in human abductions: they gently (and sometimes not so gently) float individuals from their surroundings during slumber all the while inducing a state of sleep paralysis. These abductions serve a purpose, but they are not malevolent in intent, according to the proponents of the benevolent Greys from Zeta Reticula hypothesis. SABERs assure their subjects that no harm will befall them – but are they speaking the truth? No, they are not. The SABER robots adhere to the Dragon's commands: assuming various appearances like reptilian beings, tall humans, and more. They guide the SABER Avatars in gathering human material and delivering it for processing and cellular development.

Actions, not appearances, define these entities. In the case of SABERs, their actions involve genetic manipulation to create hybrid creatures that masquerade as humans. These produced Nephilim, born of deception, blended seamlessly into our society, concealing their true nature behind human exteriors.

The progeny that is being generated by ‘Greys’ should not be misconstrued as the ‘adorable infants’ presented to those who have been abducted, which is meant either for rejection or affection. These offspring serve as nothing more than a diversion—diverting attention away from the evident truth: the actual hybrid entity, one that bears an uncanny human resemblance but possesses the essence of a Nephilim.

Much like the ancient Watchers once ensured the creation of a substantial number of Nephilim giants during the Seed War, with the intention of undermining God's flawless creation, this strategy has been adapted for contemporary times. These new Nephilim entities defy easy identification as non-human beings. For, concealed beneath their human exteriors, lie the same enduring objectives of avarice, desire, and destructive intent synonymous with Nephilim.

As we ponder the existence of these entities, one question lingers: Where is the army of Nephilim, born from countless abductions over these past 80 years? Could they be hiding in plain sight, interwoven into our lives—indistinguishable from the rest of humanity?

Robert Bigelow, a prominent figure in aerospace and UFO research, suggests that the Nephilim live among us, camouflaged in society's fabric. “They’re walking among us; they live right here,” Bigelow states to his interviewer James

Fox. Identifying the Nephilim proves nearly impossible, for they are “in plain sight” and share our appearance.
